We perform monthly reviews to ensure our legal documents are current, maintaining strict compliance with laws and regulations.

Policy and Implementation: We enforce stringent policies within our supply chain, adhering to our Responsible Business Conduct Policy, which is in line with the standards of the RJC (Responsible Jewellery Council). These policies are supported by an extensive due diligence process for our suppliers, particularly those in regions prone to issues surrounding conflict minerals. Our RJC representative regularly reviews and updates these policies to align with the latest industry standards and practices.

Reporting: İstor Kuyumculuk commits to transparency in communication with all stakeholders, providing comprehensive annual reports that detail our compliance with RJC standards. Our reporting processes are designed to build transparency and trust, keeping all stakeholders well-informed of our policies, practices, and developments.

This includes implementing Know Your Counterparty (KYC) procedures for all our suppliers and business partners, overseen by our RJC Compliance Officer.
